

The Convenor welcomed the faculty members and External Experts. Thereafter the agenda item was taken up for discussion.








Agenda Item: Syllabus revision for CBCS Pattern in the M.A. Programme/course of Sociology for the Session 2020-21 onwards [In the light of letter no. (i) DIC/2020/CBCS/ 272, dt. 04.07.2020/CBCS/487 (ii)/Manyate/2404, dt. 19-12-2020 (iii) DIC/2020/CBCS/487, dt. 24.12.2020].

The draft of revised course structure/syllabus as per CBCS pattern for Postgraduate programme/semesters of Sociology, updated and revised as directed by the university (vide letter no. Affl. /BOS / Sociology / 2020/2429, dt. 28.12.2020), was put up before the Board and discussed at length. The members made several suggestions to improve upon the draft syllabus, which included the following -

1. The nomenclature of Paper-1 in M.A. Second semester - 'Indian Sociological Thinkers' may be modified as 'Indian Sociological Thoughts'.
2. In Paper-1 of M.A. Semester-1, that is 'Classical Sociological Thinkers', the thinkers should be arranged in a chronological order.
3. The referencing of all recommended books in all papers should be done in chronological order and in proper manner. Some latest book should be introduced in all papers.
4. Supplementary list of latest books may be added at the earliest.

Resolution: The Board of Studies resolved to approve the finalized structure and syllabus of the MA course in Sociology for implementation from the academic session 2020-21 onwards. Moreover, the Board authorized the convener to make changes in the pattern of questions papers, if required, as and when directed by the university. The Board authorized the Convener to suggest the panel of Examiners for the Examination till the next meeting of the Board of studies (Sociology).
