17.Academic bank of credits (ABC):

Kumaun University is committed to adapting to the progressive changes in the educational landscape. We have therefore implemented the Academic Bank of Credits (ABC), in line with the recently implemented National Education Policy (NEP) 2020. This initiative opens up vast avenues for our students to personalize their learning paths.

We encourage our students to avail themselves of online courses offered under National Schemes like SWAYAM, NPTEL, etc., thereby supplementing their formal education with a wide array of subjects outside their chosen disciplines. This facilitates an interdisciplinary approach to learning, broadening their knowledge base and enhancing their academic prowess.

The revised curricula, applicable for students admitted in the session 2022-23 and onwards, seamlessly integrate the ABC system. Students can earn credits from various courses and store them in the Academic Bank of Credit. This ensures that their learning progress is securely recorded and acknowledged, even if they transition across institutions or take a break in their academic journey.

Kumaun University's registration with the Academic Bank of Credit is a testament to our commitment to offer flexible, inclusive, and learner-centric education, designed to empower our students in their pursuit of knowledge.

18.Skill development:

For the academic year 2022-23, Kumaun University took significant steps under the NEP 2020 to enhance its skill development courses. This included the introduction of new programs and enriching existing ones to cater to the diverse needs of the students and the community. The University offered innovative training programs to farmers and aspiring agriculturists on advanced agricultural techniques including organic farming, medicinal plant farming, and mushroom farming.

Further, the University continued to deliver B. Voc courses that are inherently skill-based, covering domains such as hotel management, hospitability, and automobile engineering. 2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

Kumaun University students belong to diverse socio-economic and backgrounds and consequently,learning capacities differ. The University faculty ensures identification of the slow, average and advanced learners and adopts a need-based approach, in choosing teaching and assessment mechanisms. The faculty members interact with the students at the commencement of the new session in both formal and informal mode to ascertain their learning needs and skills. Each department organizes an informal induction/orientation programme for its newly admitted students to familiarize them with the course structure, faculty, staff, facilities and overall environment. Students from senior batches are motivated to help the new entrants through friendly interactions. As the session progresses, the students who are identified as slow and average learners, are encouraged by their teachers to approach them with their academic queries even after the class hours as part of theremedial efforts. The advanced learners are constantly encouraged, motivated and mentored by their respective faculty members to prepare for the competitive examinations at the state / national /international level such as GATE, NET, SET, GRE, CAT and Civil services examinations. The faculty members also organize quizzes, debates, group discussions, group assignments etc. for the students to improve their learning ability.

Kumaun University has adopted the semester system to continuously assess the performances of the students. The University has developed a well-established process for the conduct of semester examinations, declaration of results and award of degrees and diplomas facilitated by the examination centre of the University which is largely automated. At the graduate and postgraduate level, the internal assessment is carried out (20-25% marks). The practical examinations are also conducted with the help of external examiners. Kumaun University maintains transparency in its evaluation process by providing -an open access to Ordinances and Regulations -provision of scrutiny / re-evaluation -evaluated answer scripts through RTI application The examination system of Kumaun University has been automated, Online student registration, date sheet of examinations, full examination schedule, issuing of admit cards and the results are all available online on the University's website. The University also has a provision of improvement / back examinations as a second chance for the students to improve their grades. Technology has been efficiently integrated into the examination system. All the degrees are awarded in two languages -Hindi and English.

Kumaun University is equipped with adequate facilities for teaching learning as evident from the audio-visual facilities available across various departments, computer laboratories, ICTenabled teaching through Smart Classrooms, access to e-learning and open learning resources inthe hostels, subscription of online and ejournals through UGC-Inflibnet consortium, Science Direct and Kluwer etc as per statutory guidelines. Around 4500 e- journals provided by SHODH GANGA have already been subscribed to by the Central library and it has already initiated the process of digitization of University publications like Annual Reports, Magazines and Newsletters. Subscription of Web of Science citation database along with Emerging science index, Conference proceeding index-Science, Conference proceeding index-Social Science and book citation index has been initiated. There is a provision ofdigitization of doctoral theses, institutional repository for the intellectual outputs and availability of online resource materials by ensuring the free access to E-resources through Inflibnet. The Central Library and Campus Libraries of Nainital and Bhimtal campuses have been largely digitalized.

The campuses of Kumaun University have several multipurpose seminar/ conference halls including: D.S.B. Campus, Nainital (Physics Seminar Hall-450 sq feet, Geology Seminar Hall-600 sq feet, New Arts Hall-1080 sq feet, Women Study Centre Hall-720 sq feet). These seminar halls are equipped with addressing systems, LCD projectors etc to organize various academic and cultural events. In addition, the mega-auditorium at the D.S.B. Campus, A.N. Singh Hall (12000sq feet area), is a majestic, spacious, smart auditorium with a seating capacity of 950 and equipped with all modern amenities, Bhimtal Campus Auditorium (1500 sq feet with seating capacity of 100) , HRDC Auditorium (1200 sq feet) accommodate the students gathering and organize events like convocation etc. These facilities provide an enviable dais to the speakers during the academic events and convocation ceremony, also to the students for showcasing their talent during various cultural and literary events. Tomark the 150th anniversary of Mahatama Gandhi in 2019, Kumaun University established the Gandhi and Indian Diaspora Studies Centre to preserve his great legacy. The University set up 'Swami Vivekanand Peeth' in 2019 at the Hermitage, Sleepy Hollow, Nainital, to impart the ideas and thoughts of the great spiritual guru through various events and activities.

ICT-enabled teaching through smart classrooms. The campuses of Kumaun University have several multipurpose seminar / conference halls includingPhysics Seminar Hall-450 sq feet, Geology Seminar Hall-600 sq feet, New Arts Hall-1080 sq feet, Women Study Centre Hall-720 sq feet). The facilities for physical education and sports activities include Gymnasium (01), Playground (01; 80x40m), BadmintonCourt (01; 20x44 feet), Basketball Court (01; 15x28 m) and Table Tennis Hall (01). Kumaun University has a well-defined and systematically executed process for maintaining and utilizing physical, academic and support facilities. There is an adequate strength of technicians, administrative office staff and lab assistants to assist in efficient functioning of campus departments, classrooms, laboratories, library, sports complex, administrative offices, buildings and ICT infrastructure. Kumaun University purchases computers, peripherals, equipment etc from reliable vendors and ensures that the IT hardware and software are maintained properly either through maintenance contracts or through its own personnel. A dedicated team of Technical Assistants and Lab Assistants provide support services relating to Scientific Laboratories. The University has adequate staff for cleaning and supervising duties, skilled jobs like plumbing, electricity repairs and backup power system, repairing maintenance of equipment and utilities, and for horticulture work. A pivotal measure is the establishment of the Women's Study Centre in 2011, revamped in 2017, which focuses on women's empowerment and social justice. It has organized national seminars, like the one in March 2022 on "Assisting women in identifying abusive relationships," raising awareness about protection against domestic violence.

A fully functional Internal Complaints Committee for Women (ICC-Women) addresses complaints and grievances of female employees and students, ensuring a safe and respectful environment. The institution has also reinforced security for female students by installing CCTV cameras at strategic locations across campuses and hostels. Academically, the Department of Sociology has introduced a course on "Gender and Society" at the PG level, promoting discourse on gender-related issues. Additionally, common rooms for female students foster socializing and unity.

The university also provides health services with functional dispensaries for medical emergencies. Counselling services are available for students at admission level, guiding them about academic growth and addressing other relevant issues. These initiatives demonstrate Kumaun University's commitment to fostering gender equity in its environment.

Kumaun University is committed to maintaining a green campus by implementing diverse waste management systems. The university segregates solid waste into biodegradable and non-biodegradable categories to ensure efficient disposal and recycling. Rainwater harvesting tanks and vermi-compost pits have been installed across the campuses to promote water conservation and organic waste recycling.

The university's sewage disposal system is linked to Nainital Municipality's main drainage system, facilitating effective liquid waste management. Measures are also in place to prevent wastage of drinking water, with surplus water being used to maintain campus greenery.

In terms of e-waste management, the university minimizes electronic waste by promoting the use of digital communication for official documents. Awareness workshops conducted by students encourage waste minimization and recycling practices.

Notably, the university's 'Nano Science and Nano-Technology' Centre at the Chemistry Department utilizes plastic waste to produce nano hydrocarbons, demonstrating an innovative approach to non-degradable waste management.

The university's holistic approach to waste management, including solid, liquid, biomedical, e-waste, waste recycling, and handling of hazardous chemicals and radioactive waste, not only protects the environment but also instills a sense of responsibility among students, faculty, and staff.

The advanced learners are constantly encouraged, motivated and mentored by their respective faculty members to prepare for the competitive examinations at the state / national /international level such as GATE, NET, SET, GRE, CAT and Civil services examinations. Tomark the 150th anniversary of Mahatama Gandhi in 2019, Kumaun University established the Gandhi and Indian Diaspora Studies Centre to preserve his great legacy. The University set up 'Swami Vivekanand Peeth' in 2019 at the Hermitage, Sleepy Hollow, Nainital, to impart the ideas and thoughts of the great spiritual guru through various events and activities.

The University has a well-defined and systematically executed process for maintaining and utilizing physical, academic and support facilities viz. laboratory, library, sports complex, computers and classrooms etc. The University ensures regular maintenance and upkeep of all infrastructural facilities with help of trained and experienced staff. ICT-enabled teaching through smart classrooms. The campuses of Kumaun University have several multipurpose seminar / conference halls includingPhysics Seminar Hall-450 sq feet, Geology Seminar Hall-600 sq feet, New Arts Hall-1080 sq feet, Women Study Centre Hall-720 sq feet). The facilities for physical education and sports activities include Gymnasium (01), Playground (01; 80x40m), BadmintonCourt (01; 20x44 feet), Basketball Court (01; 15x28 m) and Table Tennis Hall (01). The main library operations(acquisition, catalogingand circulation, etc) have been automated and the Online Public Access Catalogue (OPAC) is used. The library users have access to a large number of eresources based on IP access module .The Digital Network platform (E-Granthlaya) is also being used. It has been using different LMS (Library Management Software) for automation i.e. CDS/ISIS, SOUL and ALICE for Windows since 2005. The Library has digitized 850 books published before the year 1950 under the C-DAC project. All hard bound theses prior to 2005 have been digitized by the library. In the Central Library at Nainital UGC INFONET E-journals on different subjects have been made available.Subscription of Web of Science citation database along with Emerging Science index, Conference Proceeding Index-Science, Conference Proceeding Index- Social Science and Book Citation Index has been initiated. The Library uses anti plagiarism web tool namely URKUND Plagiarism Checker to promote authentic and quality research works and check plagiarism in doctoral theses and research papers.

Kumaun University has actively taken initiatives to promote gender equity. A pivotal measure is the establishment of the Women's Study Centre in 2011, revamped in 2017, which focuses on women's empowerment and social justice. It has organized national seminars, like the one in March 2022 on "Assisting women in identifying abusive relationships," raising awareness about protection against domestic violence.

A fully functional Internal Complaints Committee for Women (ICC-Women) addresses complaints and grievances of female employees and students, ensuring a safe and respectful environment. The institution has also reinforced security for female students by installing CCTV cameras at strategic locations across campuses and hostels.

Academically, the Department of Sociology has introduced a course on "Gender and Society" at the PG level, promoting discourse on gender-related issues. Additionally, common rooms for female students foster socializing and unity.

The university also provides health services with functional dispensaries for medical emergencies. Counselling services are available for students at admission level, guiding them about academic growth and addressing other relevant issues. These initiatives demonstrate Kumaun University's commitment to fostering gender equity in its environment.

Kumaun University is committed to maintaining a green campus by implementing diverse waste management systems. The university segregates solid waste into biodegradable and non-biodegradable categories to ensure efficient disposal and recycling. Rainwater harvesting tanks and vermi-compost pits have been installed across the campuses to promote water conservation and organic waste recycling.			
The university's sewage disposal system is linked to Nainital Municipality's main drainage system, facilitating effective liquid waste management. Measures are also in place to prevent wastage of drinking water, with surplus water being used to maintain campus greenery.			

In terms of e-waste management, the university minimizes

electronic waste by promoting the use of digital communication for official documents. Awareness workshops conducted by students encourage waste minimization and recycling practices.

Notably, the university's 'Nano Science and Nano-Technology' Centre at the Chemistry Department utilizes plastic waste to produce nano hydrocarbons, demonstrating an innovative approach to non-degradable waste management.

The university's holistic approach to waste management, including solid, liquid, biomedical, e-waste, waste recycling, and handling of hazardous chemicals and radioactive waste, not only protects the environment but also instills a sense of responsibility among students, faculty, and staff.

This centre provides free counselling to the underprivileged, raising awareness about their constitutional rights and the judicial system. The faculty ensures its representation in the State Legal Services Authority (SLSA) and District Legal Services Authority (DLSA).

The university also organizes state-level Moot Court Competitions and debates on free legal aid in association with SLSA, supervised by DLSA. Furthermore, B.A.LL.B (Hons) students, serving as Para Legal Volunteers, engage in community sensitization about basic rights and the workings of Lok Adalat and Free Legal Aid.

Moreover, the UG and PG curriculum across various departments, including Political Science, Journalism, Mass Communication, and Law, incorporates subjects aimed at raising awareness and knowledge about the students' civic duties, rights, and responsibilities. These initiatives reinforce Kumaun University's commitment to creating responsible and informed citizens.
