Dear Colleagues

Greetings from the office of the Vice Chancellor!

Please accept my best wishes to you and your dear ones on the occasion of Diwali and the forth coming festive season. I would like to inform you that the finance committee of Kumaun University approved the following initiatives (subject to the approval of the Executive Council) in the interest of the University and Students.

12.A provision has been made to provide internal funding for research to all permanent faculty members. The funding for the Sciences will be Rs. 1,00,000 and for Arts/Humanities, it is Rs. 75,000 (which may change based on the number of projects and amount of money available). Detailed project proposals (including list of publications in last five years) for a one-year duration should be submitted to the **Director of the Research and Development Centre (RDC)**. The proposals would be screened by an expert committee. The research funding would be extended to the recommended proposals based upon the quality of work and the available funds under this head.

- **Eligibility:** Principal Investigator (PI) from the science departments should have published at least 05 papers in SCI/Scopus/Web of Science/Clarivate indexed journals during the last 05 years. The PI from Arts, Humanities, Social Science, Law, Commerce, and Management should have published 05 papers in the journals which are indexed in the Scopus or UGC care list, or 02 books or 04 book chapters in the international publishers with ISSN/ISBN numbers, during the last 05 years. **OR**
- The PI who has completed successfully a sponsored project funded by state/national/international agencies, or has a patent granted (individual or institutional capacity), shall also be eligible for submission of the research proposal.

2. The progress of each faculty member will be evaluated after one year on certain Key performance Indicators (KPIs), making them eligible for further funding.
3. Internal funding to attend reputed Conferences and Symposia for delivering invited talks has been also provisioned. The active researcher's are eligible once in every two years for funding to deliver invited talks in conferences or symposia located within a 500 KM radius. The funding shall cover the reimbursement of Rs 5000/- registration fee, AC-II train and/or bus fare, and DA as per rules. The same can also be extended to contractual/guest faculty who hold a Ph.D. degree and have research credentials evident from fellowships and publications. Active researchers will also be eligible for reimbursement of Rs 50,000/- for delivering talks in international conferences once in every three years. However, the organizing society must not fall under the category of predatory society. Prior approval of the University must be obtained.
 - **Eligibility:** A faculty member active in research can be granted a registration fee (up to Rs. 5000/- maximum) and II AC train fare for the presentation of a paper as an invited speaker in the national event, provided he/she has published 03 papers in SCI/Scopus/UGC care listed journals during the preceding three years, with the distance of the place is less than 500 km and financial support will be given once in two years, however, it can be relaxed by the Vice Chancellor.
 - A sum of Rs. 50000/- maximum to the individual faculty active in research who has published 06 papers during the last three years in Scopus/SCI indexed journal, shall be granted once in three years for invited talk in the international conference. The sanctioned amount can be used for the purpose of registration fee/travel/stay charges. An advance amount can be granted to the candidate depending on the merit and need of the case. The adjustment of the advance must be submitted within one month from the end date of the event. Prior approval of the University must be obtained.
4. Each research group will receive financial assistance to send two PhD students to present their research paper or poster within a 500 KM radius. The financial assistance will include reimbursement of the Rs 3000/- registration fee, sleeper class and/or bus fare, and accommodation in hostels/guest houses. It is important to note that the organizing society should not be a part of the predatory category. Prior approval of the University must be obtained.
 - **Eligibility:** For Ph.D. students and post-doctoral fellows, the registration fee shall be limited to Rs. 3000/- maximum and sleeper class train fare and/or bus fare as per rule, provided student has published at least one paper in the SCI/Scopus/UGC care listed journals during the tenure of research at the time of application, with

the distance of the place is less than 500 km. Students may be invited for the presentation of paper or poster. Two students from each group and financial support will be given once in two years.

5. Indian patent filing fee will be paid by the University. A separate funding provision has been made for the same, so faculty members are encouraged to file patent for the innovation that may have commercial value. Detailed proposal should be submitted for the same.
6. Provision of Honorary Professors and Visiting Professor has been initiated. Each Department can nominate one Indian and one Foreign Professor. For visiting Professors (Indian), the nominated person should be a fellow of at least two science academies and for arts/humanities, the nominated Professor should be the recipient of a National-level award like Padmasree or national award or national professorship. Such Professors will be entitled to travel allowance, accommodation and Rs 3000 per lecture of 1.5 hr duration. While nominating such Professors, the department should identify the areas of research and teaching where they want the expertise of the invitee.
Under the foreign category (Honorary Professor), the nominated Professor should be an expert in the area and will be paid 100 USD per lecture (online). Industry personnel can be nominated as Honorary Professor and such people shall be provided accommodation in the Guest House, such invitee will have to help the University under the CSR funding. Senior bureaucrats, Judges, and Indian army/paramilitary personnel can also be nominated under the category of Honorary Professor. The head of the Department after consultation with the faculty members, **should submit a two-page CV of the nominated personnel to the office of the Dean, Academic Affairs by November 25, 2023.** All such nominations will be scrutinized by the committee constituted for the purpose.
7. Provision of funding for the bachelor/master students under the Talent Hunt Program has been initiated and detailed guidelines for the same will be communicated in due course. Implementation of these initiatives is subject to the approval of the Executive Council of Kumaun University.
8. The faculty members publishing the research papers in the journals with impact factor 3-5, above 5-10, and >10 (impact factor by Thompson and Reuters/Clarivate) shall be given Rs. 3000/-, 5000/- and 7500/- respectively (to be shared between first author and PI).
9. Faculty member generating funds through consultancy/technology transfer by intellectual exchange of ideas: Out of the revenue generated 50% shall be given to the faculty member to be used for the research purpose or can be distributed among the team members (60% to PI and 40% to the team members). An appreciation certificate will be given to the team members.

10. The faculty members for each granted patent shall be given Rs. 7500/- (originated from the host institution i.e., Kumaun University, Nainital). For filing the patent originated from Kumaun University, shall be granted the desired fund (the prize amount shall be shared as: 60% to PI and 40% to the team members).
11. Publication fees for journals with an impact factor of more than three and Q1 and Q2 journals (Springer Nature, Elsevier, RSC, Wiley or equivalent publishers) in the subject field can be reimbursed up to 50% or 25000/- whichever is less, per paper. Before submission to such paid journals, approval of the University must be obtained.

Proposals for the point no 1 and 6 should be submitted by November 25, 2023.

I hope these initiatives will create a vibrant academic environment and foster a new era of research culture in the University and help us to achieve set targets. Let's join hands to do something for our temple of learning.

The PI has successfully completed a sponsored project funded by state/national/international agencies on the date of application. Or,

PI has a patent granted (individual or institutional capacity) on the date of application for this grant

(ii) For PI from Arts/ Humanities/Social Sciences/Law/Commerce/Management must have at least 03 research papers published in the UGC CARE list/SCI/Scopus/Web of Science indexed research journals during the last 05 years (March 2019 onwards) on the date of application for this grant Or,

02 books or 04 book chapters in International Publishers with ISSN/ISBN during the last five years (March 2019 onwards) on the date of application for this grant.

B. The amount of the Grant:

For Science/ Technology/ Agriculture: Rs. 1,50,000.00 (Rupees one lakh fifty thousand only)

For Arts/ Humanities/Social Sciences/Law/Commerce/Management: Rs. 1,00,000.00

(Rupees One lakh only)

C. Duration of the Project: One Year from the date of issue of the sanction letter.

D. Terms and Conditions of Proposals: As modified/ will be modified and passed by the Steering/ Coordination Committee

Decision:

The PI has to appear before the committee and satisfy them regarding the need for the equipment and get their consent.

: Terms & Conditions of the Grant

Kumaun University Internal Funding for Research 2023-2024

(Terms & Conditions of the Grant)

1. Kumaun University will maintain separate audited accounts for the project and the amount of the grant will be preferably kept in a bank account earning interest.
2. Approval of the research proposal and the grant being released is for the specific project sanctioned and should be exclusively spent on the project-related activities within the stipulated time.
3. The grant will be released in one installment after the acceptance of the terms and conditions laid down by KU.
4. The grant shall not be utilized for construction and repair/maintenance of any building unless a specific provision is made for that purpose. The respective department will be responsible for full infrastructural facilities by way of accommodation and space, water, electricity, communication, etc. that are essential for the smooth implementation of the project.
5. The Principal Investigator (PI) shall ensure that the fund released towards the project is used exclusively and appropriately in support of the research project for which it has been sanctioned. No fellowship is permissible out of the fund allocated.
6. The equipment/ camera/ desktop/laptop/printer/furniture as proposed in the research proposal can be procured only after getting the prior consent of the competent committee which will take up the matter on a case-to-case basis.
7. Any expenditure incurred before the issue of the financial sanction/approval order and after the expiry of the sanctioned duration of the project will not be admissible.
8. The PI will furnish a Progress Report of the work on the project after six months of the release of the project grant, and a final Report within three months after the duration of the project is over.
9. PI is expected to settle the accounts within 3 (three) months from the date of completion of the project.
10. A separate ledger is maintained for the purchasing of equipment/Instruments as per the provision of GFRs.
11. The following documents need to be sent to the RDC after the project duration is over:

- a. Final Consolidated Statement of Expenditure giving expenditure from date of start till date of completion.
 - b. Utilization Certificates matching with Statement of Expenditure
 - c. Three copies of the Project Completion Report (PCR) with publication list, patents filed/ likely to be filed, Doctorates from the project and other manpower trained along with one softcopy of the PCR including an Executive Summary; and
 - d. List of assets acquired through Capital grants.
12. Any unspent balance out of the amount sanctioned must be left saved in the University account.
13. All the assets acquired from the grants can be considered on the Departmental Inventory list and should not be disposed of or encumbered without the prior sanction of RDC/University. However, the RDC/University has the discretion to allow other Investigators from the respective or other departments to utilize the assets for projects sanctioned by the RDC/University.
14. RDC/University may designate Professors or an Expert Panel to visit the Departments periodically to review the progress of the work being carried out and to suggest suitable measures to ensure realization of the objectives of the project.
15. The PI is expected to attend Monitoring Meetings/Workshop to present the progress/outcome of the research project, as and when organized.
16. Kumaun University reserves the right to terminate the project at any stage if it is convinced that appropriate progress is not being made or the grant has not been properly utilized.
17. The project becomes operative within 15 (fifteen) days from the date on which the project grant is received by the PI.
18. If the PI to whom a grant for a project has been sanctioned, wishes to leave the University the PI will inform the same to RDC/University immediately and will ensure that the Co-PI, if any is appointed in consultation with the RDC who can take over the responsibility of project implementation. This consultation with RDC needs to be done before relieving the PI.
19. If the PI wishes to terminate the project being implemented/leave the University he/she shall inform the RDC immediately. No further installment/s will be released from the date of termination of the project or the date of resignation of PI. The unspent balance out of the amount sanctioned must be returned to the University.

20. Investigators are encouraged to publish technical/ scientific papers based on the research work done under the project in journals of high repute. They should formally acknowledge the assistance received from Kumaun University. The PI also has the responsibility of informing the RDC/IQAC/University about any papers published from the project implementation even after the completion of the project tenure.
21. The projects that have the potential for generating know-how in the form of product/ process/ design etc. through patents, copyrights, etc. should preferably follow the University's guidelines for patenting/ copyright. A copy of any such application should also be sent to the RDC/University.
22. IPR generated through the sanctioned projects will be owned by the University. The University will be the applicant for the patent and the PI can be the inventor.
23. The PI has to send the acceptance with the Terms and Conditions of KU Internal Funding for Research Grant sanction letter so that the aforementioned grant can be credited to the designated account.
24. At least one quality Publications are expected from the project. For the Science stream, the publications should be in SCI/ Scopus indexed journals, and for Arts it should be in Scopus/ UGC CARE Listed journals.
25. The publication from the project must bear the acknowledgement "With financial Assistance from Kumaun University".
