Awareness and Prevention Strategies

1. Banners and Posters

- Strategic placement of informative banners and posters across the campus to continuously remind students about the university's strict stance against ragging and sexual harassment.
- Posters include helpline numbers, contact details of committee members, and steps to report incidents confidentially.

2. Nukkad Natak (Street Plays)

- Regular organization of engaging street plays to educate students about the severe consequences of ragging and sexual harassment.
- These performances highlight real-life scenarios, legal repercussions, and support mechanisms available for victims.

3. Lectures and Workshops

- The concerned committees organise lectures and interactive workshops to inform students about their rights and responsibilities.
- Experts and committee members provide insights into the psychological, social, and legal aspects of ragging and sexual harassment.
- Special sessions are held during orientation programs for new students to inculcate a culture of respect and safety from the outset.

- Support for Victims: The university provides counselling and support services to victims of ragging and sexual harassment.

Disciplinary Measures

- Strict penalties including suspension, expulsion, and legal action against perpetrators.
- Regular reviews and updates to the disciplinary code to align with national laws and best practices.

Punishment for the Students involved in Ragging:

- Suspension from the classes
- Scholarship will be held back/ terminated
- · Prohibition from writing any test or exam
- The exam result will be held back.
- · Will be prohibited to represent any meeting/tournament/ youth festivals.
- · Suspension/ expulsion from the hostel.
- · Prohibition from the admission.
- · Temporary suspension from the institution.
- Expulsion from the institute and prohibition from taking admission in any other institute.


